JULY 14, 2011 TOWN BOARD MEETING

The Town Board of the Town of Stuyvesant held its monthly meeting on Thursday, June 9, 2011 the Stuyvesant Town Hall. In attendance at the meeting were Supervisor Valerie Bertram, Councilperson Brian Chittenden, Councilperson Ronald Knott, Town Clerk Melissa Naegeli and Attorney for the Town Tal Rappleyea. Highway Superintendent Bernie Kowalski was not in attendance.

Supervisor Bertram called the meeting to order at 7:00pm and began with the Pledge of Allegiance.

A motion was made by Councilman Ronald Knott to approve the minutes of the previous meeting with the necessary changes to the heading of "*Greenway Committee*". The motion was seconded by Councilman Brian Chittenden and was approved unanimously.

A motion was made by Councilwoman Kelley Williams to approve the bills. The motion was seconded by Councilwoman and the motion was approved unanimously.

Supervisor Bertram announced that we would begin with some special presentations by Town Historian Juanita Knott. Mrs. Knott presented the newly published <u>Stories of Stuyvesant</u> history book to the Columbia County Historical Society; Past Town Supervisors; the ICC Libraries; Kinderhook Memorial Library and the Valatie Free Library.

Mrs. Knott reminded everyone that the Historic Stuyvesant Day festivities will take place at the Stuyvesant Falls Sandbar on Saturday, August 13th. Hot dogs and salads will be provided by the Town and everyone is asked to bring a dessert to share.

Supervisor Bertram expressed thanks from the Board for all of Mrs. Knott's hard work on the book and Historic Stuyvesant events.

Town Clerk

Councilwoman Kelley Williams reported that there are 50 children attending the Town of Kinderhook Summer Program.

Railroad Restoration Committee

Marilyn Burch reported that the Corn Festival will be held on Saturday, August 6th. She also reported that the Farmers' Markets are being held on the first Saturday of each month. Mrs. Burch requested permission to advertise 1 or 2 times per month in the register star at a cost of \$42 each time. A motion

to approve the request was made by Councilman Ronald Knott and seconded by Councilman Brian Chittenden. The motion was approved by unanimous vote.

Planning Board & Zoning Board

Shirley Narzynski reported that there will be a special Zoning Board of Appeals meeting on Tuesday July 19, 2011 at 7:00pm regarding the Glencadia Dog Camp.

Councilman Ronald Knott reported that he and Councilwoman Kelley Williams had interviewed the one person who had submitted a letter of interest for the Zoning Board vacancy. He made a motion to appoint Kent Keller to the vacant seat on the Zoning Board of Appeals. The motion was seconded by Councilwoman Kelley Williams and was approved by unanimous vote. Mr. Keller will be notified of the appointment and will be asked to make arrangements to be sworn in by the Town Clerk.

Town Hall Committee

Councilman Knott reported that the large Zoning Map in the meeting room had been updated and printed by resident Tom Davis. The Board expressed their thanks to Mr. Davis. The map shows 200 more acres of preserved land in the Town.

SPECIAL PRESENTATION

Ray Jurkowski, Engineer from Morris Associates regarding the proposed Capital Project for the highway garage and salt sheds. The referendum vote will be held on August 16th from 2-9pm at the Town Hall.

Mr. Jurkowski gave a lengthy power-point presentation that gave updated information and numbers for the project. The cost cap for the project is \$845,000.

The information presented to the Board will be available on the website.

At the conclusion of Mr. Jurkowski's presentation, Supervisor Bertram said she would like to mail a letter out to the residents explaining the project and the necessary details before the vote. A motion to mail a letter was made by Councilman Ronald Knott and seconded by Councilman Brian Chittenden. The motion was approved by unanimous vote.

SPECIAL PRESENTATION

The Board of Election Commissioners Jason Natsky and Virginia Martin asked to make a brief presentation to the Board and audience. They reported that the County Board of Elections has been conducting a county-wide evaluation of polling places as a way to reduce costs. After reviewing the results, the decision has been made to close St. Joseph's Church as a polling place. Both Districts will now vote in the Town Hall but will remain as two separate districts.

Old Business

Supervisor Bertram read the following resolution regarding hiring Whiteman, Osterman & Hanna, LLP:

WHEREAS, the Town Attorney recommended that the Town Board retain special counsel to represent the Town in all matters relating to the Glencadia Dog Kennel and its owner and/or operator (the "Glencadia matters"); and

WHEREAS, the Town Board agreed that the Town required continuing legal representation in the Glencadia matters, which have included, on an ongoing basis, at least one lawsuit against the Town, multiple proceedings before the Town Planning Board and the Town Zoning Board of Appeals, at least one proceeding before the Town Justice Court; multiple Notices of Violations issued by the Zoning Enforcement Officer; numerous legal issues raised by members of the public and the owner and operator of Glencadia; numerous and constant FOIL requests for Town records; and a variety of other continuous legal work; and

WHEREAS, at the Town Board meeting on February 10, 2011, the Town Board took action to appoint the law firm of Whiteman Osterman & Hanna LLP as special counsel to represent the Town in all Glencadia matters and authorized the Town Supervisor to enter into an agreement, on behalf of the Town, with Whiteman Osterman & Hanna, LLP for such legal services; and

WHEREAS, on March 10, 2011, the Town Supervisor, on behalf of the Town, signed a retainer agreement with Whiteman Osterman & Hanna LLP for the provision of legal services in connection with the Glencadia matters; and

WHEREAS, certain members of the public have raised questions regarding the appointment of Whiteman Osterman & Hanna LLP as special counsel for the Town; and

WHEREAS, notwithstanding the fact that the Town Board believes that it complied with all applicable laws in appointing Whiteman Osterman & Hanna LLP as special counsel, the Town Board hereby elects to ratify the action taken in making such appointment.

NOW, THEREFORE, BE IT RESOLVED that the Town Board hereby reaffirms and ratifies the appointment of Whiteman Osterman & Hanna LLP as special counsel to represent the Town in any and all Glencadia matters and hereby reaffirms and reconfirms the continued appointment of Whiteman Osterman & Hanna LLP as special counsel to represent the Town in all such matters; and

BE IT FURTHER RESOLVED that the Town Board hereby deems all work performed by Whiteman Osterman & Hanna LLP in representing the Town in the Glencadia matters from February 10, 2011 through today to be duly authorized and hereby accepts all such work as being in conformance with the appointment as special counsel by the Town Board.
