Town Board Meeting

December 29, 2014

The Town Board of the Town of Stuyvesant held their monthly business meeting on Monday, December 29, 2014 at 7:00pm at the Town Hall. In attendance were Supervisor Ron Knott, Councilman Edward Scott, Councilwoman Kelley Williams, Councilman Brian Chittenden, Councilman Tom Burrall, Highway Superintendent Bernie Kowalski, and Town Clerk Melissa Naegeli.

Supervisor Knott called the meeting to order at 7:00pm and open with the Pledge of Allegiance.

A motion was made by Councilman Edward Scott to approve the vouchers presented for payment. The motion was seconded by Councilman Brian Chittenden and was passed by unanimous vote.

Correspondence

A letter from Kinder Morgan regarding the relocation of gas lines to out of Columbia County.

A letter from the Public Service Commissioner (PSC) explaining that there is an evaluation being done for the need for the proposed power line project.

A letter from NYS DOT regarding the Railroad Station Grant project and processing payments.

Old Business

Municipal Energy Program – Supervisor Knott reported that he had received the contract to lock into a program administered by the Association of Towns that will group municipalities to purchase electric at reduced rates. The 2 year lock-in price is \$.7655/Kwhr. Supervisor Knott asked for the Board's approval to sign the contract and enter the Town into the program, after reviewing past bills and potential savings amounts. A motion to enter in to the program and to allow Supervisor Knott to sign the contract was made by Councilman Ed Scott. The motion was seconded by Councilman Tom Burrall and was passed by unanimous vote.

County Government

Supervisor Knott reported that the end of year meeting had been held and that tax warrants had been approved. He explained the EMS Chargeback, and that Stuyvesant was \$30,303.00 – the 2nd lowest in the County. The County Organizational Meeting will be held on January 5, 2015 at 3pm.

New Business

Supervisor Knott presented to the Board a proposed Budget Amendment for \$55,669. He asked the Clerk to take a roll call vote.
