## February 12, 2015

The Town Board of the Town of Stuyvesant held their monthly business meeting on Thursday, February 12, 2015 at 7:00pm at the Town Hall. In attendance were Supervisor Ron Knott, Councilman Tom Burrall, Councilman Edward Scott, Councilman Brian Chittenden, Councilwoman Kelley Williams, and Bernie Kowalski. Town Clerk Melissa Naegeli was not in attendance.

Supervisor Knott called the meeting to order at 7:00pm and open with the Pledge of Allegiance.

Supervisor Knott asked for a Moment of Silence for Town residents who had passed away.

## Correspondence

Supervisor Knott reported that he had received proposals for the power lines. The Guest Speaker from National Grid cancelled. Supervisor Knott will meet next week with energy companies.

A check from NYMIR for \$544 was received.

#### **Old Business**

*Lincoln Funeral Train* – Supervisor Knott reported that the Press Conference with Congressman Gibson would be held on Monday to kick-off the Lincoln Funeral Train events. A full brochure is in the Town Clerk's Office.

Fund CDEC – donations and checks are now being accepted. Information will be put on the website how to do this. A \$500 check from the Ken Hummel Memorial Run was donated to the Lincoln Funeral Train Committee.

Checks have been distributed, according to the Budget, to the Fire Companies, the Library, the Seniors and the Garden Club.

There is still a vacancy for the Secretary position for the Planning & Zoning Boards.

*Ice House Road* – the gates and lights at the crossing are now operational. Supervisor Knott will be meeting with DEC to talk of a ribbon cutting in the Spring.

Monolith Solar - The usage and production real-time reports will be made available on the Town website.

Albany Engineering – We have received our annual payment of \$10,000.

A motion to approve the bills presented was made by Councilman Tom Burrall, seconded by Councilman Ed Scott and was approved by unanimous vote.

Town Clerk: Town Clerk & Tax Collector reports are on file.

*Recreation Committee:* Councilwoman Williams reported that the ice rink has been put on hold until next Winter. The Lincoln Funeral Train events were discussed.

Highway Department: Superintendent Bernie Kowalski reported they are almost out of salt and 900 ton of material has been used. They are still plowing snow and drifts, the truck body is expected next week.

*Historian*: End of Year report is on file. Ice House Road will be the site for the 2015 Historic Stuyvesant Day picnic – the theme has not be decided.

Cemetery: Councilman Edward Scott reported that all was quiet.

Building Inspector/CEO: Gerry Ennis reported that the deadline for the clean up of the burnt house in Stuyvesant Falls has passed. He has asked the Board and Attorney about an unsafe building law.

Town Hall: A locksmith had come in to check the back door.
