The Town Board of the Town of Stuyvesant held their End Of Year meeting on Wednesday, December 28, 2016 at 7:00pm at the Town Hall. In attendance were Supervisor Ron Knott, Councilman Brian Chittenden, Councilwoman Kelley Williams, Councilman Edward Scott, Councilman Tom Burrall, Town Clerk Melissa Naegeli, Highway Superintendent Chuck Stiffler, and Attorney for the Town Tal Rappleyea.

Supervisor Knott opened the meeting at 7:00pm with the Pledge of Allegiance.

Supervisor Knott thanked the Stuyvesant Garden Club for decorating the Town Hall for the Holidays.

Supervisor Knott reviewed the End of Year financial report as of today. The report did not reflect the bills submitted at this meeting but did reflect the payroll. Overall, we ended under budget and there will be money going into the unexpended fund.

The edits to the Proposed Local Law for Zoning had been given to the Board members for their review. Supervisor Knott asked if the Board agreed to send the proposed Law to the NYS Dept. of Agriculture and Markets for review and to schedule a public hearing. Supervisor Knott has provided an electronic version to be put on the Town website.

Supervisor Knott announced that a NYS Comptroller Auditor had been reviewing records of the Town and that he would be back in January after the Holidays.

Supervisor Knott announced that there were new broadband maps in the meeting room.

A motion to approve the bills presented was made by Brian Chittenden, seconded by Edward Scott, and was approved by unanimous vote.

A motion to adjourn was made by Brian Chittenden, seconded by Kelley Williams and was approved by unanimous vote. The meeting adjourned at 7:20pm.
