# PUBLIC HEARING Local Law #2 of 2017 Re: Veteran's Real Property Tax Exemptions

The Town Board of the Town of Stuyvesant held a Public Hearing on August 10, 2017 at 7pm for the purpose of taking public comment on proposed Local Law #2 of 2017 regarding Veteran's Real Property Tax Exemptions.

Supervisor Knott called the meeting to order and asked Town Clerk Melissa Naegeli to read the Public Notice as it was published in the official Newspaper.

Following the reading of the Notice, Supervisor Knott reviewed the proposed law and explained that the limits of income were being increased to match the Law recently passed by the County Board of Supervisors. He explained that the proposed increase in exemptions would result in an approximate \$3/year to tax bills between the County and Town increases. The Law will also include "Gold Star Parents" as being eligible for the exemptions.

Councilman Tom Burrall asked how many people in the Town took advantage of the Veterans Exemptions currently. The Assessor's Clerk Cathy Knott responded there were 47 and that the Office could provide a breakdown for the Town Board.

Mike Naegeli commented that it was a great idea to match the Law with the County amounts.

Cathy Knott encouraged the Board to adopt the Law.

With no further comments or questions, Supervisor Knott closed the Public Hearing at 7:10pm.

The Town Board of the Town of Stuyvesant held their monthly business meeting on Thursday, August 10, 2017 at 7:00pm at the Town Hall. In attendance were Supervisor Ron Knott, Councilman Edward Scott, Councilman Tom Burrall, Councilman Brian Chittenden, Highway Superintendent Charles Stiffler, Town Clerk Melissa Naegeli, and Attorney for the Town Tal Rappleyea. Councilwoman Kelley Williams was not in attendance.

Supervisor Knott opened the meeting at 7:00pm with the Pledge of Allegiance.

A motion to approve the minutes of the previous meeting was made by Edward Scott, seconded by Brian Chittenden and was approved by unanimous vote.

# <u>Old Business</u>

*Health Insurance* – Supervisor Knott reported that there is a projected 14% increase to Health Insurance for the coming year. The Board shopped around for prices and have decided to stay with the current plan and company. The 14% increase in insurance works out to approximately 2% of salary of those affected.

*Liability Insurance* – Supervisor Knott reported that the Board had decided to ask for bids from three local insurance companies to see if there was an opportunity for better pricing.

*Resolution for Village of Kinderhook* – Supervisor Knott reported that he had shared at the Workshop meeting a proposed Resolution in support of the Village of Kinderhook applying for a Greenway Grant for development of a "creek trail" on the Kinderhook Creek. He asked for Board support to sign the resolution to join with the Village of Kinderhook to develop the Creek through our Town. Our share of the Grant would be \$3,000 approximately.

WHEREAS, the grant application requires the applicant municipality to obtain the approval/endorsement of the governing body of the municipality or municipalities in which the project will be located.

NOW, THEREFORE, BE IT RESOLVED that the governing board of the Town of Stuyvesant hereby does approve and endorse the application for a grant under the Greenway Communities Grant Program, for a project known as "Kinderhook Creek Recreational Use Study, Phase I" and located within this community and will support, cooperate and equally share in the cost thereof with all other municipalities participating therein.

that won the County Bid. After reviewing the bid from the current company, Valley Oil, it was determined that there was a \$.0025/gallon difference. The Board agreed that this was a small amount and agreed to stay with the current company.

#### RESOLUTION TOWN OF STUYVESANT Authorization for the award of fuel oil

**WHEREAS**, the Town of Stuyvesant general accepts the price per gallon of fuel based on the County's bidding process;

WHEREAS, this year the County fuel oil bid went to Kosco Oil;

**WHEREAS**, the Highway Superintendent and the Town Clerk have recommended to the Town Board that we consider remaining with Valley Oil who currently has the bid due to past difficulties in billing and delivery service; and

**WHEREAS**, upon investigation it was discovered that Valley Oil bid was only .0025 cents per gallon more than the low bidder, being Kosco.

# <u>Reports</u>

Town Clerk -- Report on file.

*Recreation Committee* -- Lee Jamison reported that volunteers had repaired the footbridge at Ken Hummel Park.

Highway Superintdent Chuck Stiffler reported that he cannot get a tree for the playground right now. He will take care of getting a tree and planting it in the Fall.

*Railroad Station Committee* – Marilyn Burch reported that the Family Movie Night would be held on Saturday, August 12<sup>th</sup> and would screen "Lawrence of Arabia". She also reported that the Corn Festival would be held on Friday, August 18<sup>th</sup> at the Town Hall.

*Environmental Management Council* –Christian Sweningson reported that the Council had received a report from the Representative of the NYS Climate Resiliency that paid attention to weather and projections to help municipalities with planning at the shorelines. Raises in temperatures are tiny but cause big impacts on storms. The Northeast is above the National average which is higher than the plant average.

Culvert overload and road flooding are being reviewed because of flooding. Money is available for upgrades. Highway Superintendent Chuck Stiffler added that he had signed up for the available classes.

Dog Control Officer – Report on file.

*Kinderhook Memorial Library* – Lee Jamison reported that the Library Capital Project had received \$200,000 from a Grant from State Senator Cathy Marchionne. The groundbreaking for the large addition is being scheduled.

*Office for the Aging* – Ida Leiser reported that the Reach Program did 20 projects locally for Seniors and did great work. The group was hindered from helping more people because of the proximity of where they were staying and the limitations on travel.

Highway Department - the Highway Superintendent Chuck Stiffler reported

- They are working on the shoulders of the newly paved roads;
- They are cutting low hanging branches along Town roads;
- They helped at Stockport with paving projects;
- CHiPs money had been applied for; and
- FEMA money had been applied for.0

Assessor's Office – Cathy Knott reported that everything was quiet.

*Planning/Zoning Boards* – Christian Sweningson report that the Zoning Board had reviewed a variance for a house on Summerset Road.

#### August 10, 2017

Marilyn Burch reported that the Planning Board had adopted a Resolution for a horsebarn to be moved back 4' from the road on Route 9.

*Historian* – Juanita Knott reported that Historic Stuyvesant Day would be on Saturday, August 12<sup>th</sup>. There would be a Commemoration of WWI Veterans by the VFW at 1pm at the Picnic at the Sandbar in Stuyvesant Falls. She added that she is working on story boards and games and activities for people to participate in at the picnic.

Lee Jamison added that she had been doing research on the Women's Land Army. She had learned that it was women who had been trained to use farm equipment and continue to grow crops to feed the military. She said it was pre-"Rosie the Riveter".

Cemetery - Councilman Ed Scott reported that mowing and trimming were continuing.

Cathy Knott reported that she had been working at the Butler Cemetery identifying and cleaning stones, with the help of her sister Maureen. She is going to prepare a map of the cemetery for the Town records.

ZEO/Building Inspector – Report is on file.

*Town Hall* – The Highway Department has been cleaning up the grounds in advance of the Ken Hummel Run. Highway Superintedent Chuck Stiffler will get bids for the crack sealing of the driveway and parking lots.

Supervisor Knott reported that Lee Jamison had presented to the Board a Resolution to support additional PCB clean up in the Hudson River. There was an extensive discussion regarding the history of the clean-up projects in the River and the agencies that supported additional clean-up. Juanita Knott recommended that the County Board of Supervisors also be asked to support the Resolution since the entire Western border of the County and may carry more weight. Lee Jamison asked the Town Board to support the Resolution and bring to the County.

Councilman Edward Scott asked why the Governor hadn't stepped in and hadn't GE done what it was asked to do. Lee Jamison reported that he DEC representative from the Governor's Office had been holding EPA and GE to the fire.

# RESOLUTION OF <u>2017</u> IN SUPPORT OF ADDITIONAL REMEDIATION AND INVESTIGATION OF PCB CONTAMINATION IN THE HUDSON RIVER

WHEREAS, on June 1, 2017, the U.S. Environmental Protection Agency (EPA) released its Proposed Second Five-Year Review Report for Hudson River PCBs Superfund site, determining that the remedy in the Upper Hudson River — a 40-mile stretch above the Federal Dam at Troy, NY — "will be protective of human health and the environment upon completion;" and

**August 10, 2017** WHEREAS, EPA did not reach a protectiveness determination for the Lower Hudson River — a 150 mile stretch below the Federal Dam; and

WHEREAS, nearly 200 miles of the Hudson River — from Hudson Falls to New York City — is a federal Superfund site because General Electric (GE) discharged millions of pounds of polychlorinated biphenyls (PCBs) into the River for thirty years, between 1947 and 1977; and

WHEREAS, PCBs are manmade, bioaccumulative, persistent pollutants that have been linked to adverse health effects including, among others: cancer, liver disorders, reduced birth weight and conception rates, persistent and significant deficits in neurological development; and

WHEREAS, the continued presence of PCBs in the Hudson River has significantly diminished economic activity and recreational use and enjoyment of the River; and

WHEREAS, New York State Department of Health has in place fishing restrictions and advisories against consumption of fish to control human exposure pathways that could result in unacceptable risks; and

WHEREAS, some may believe that the EPA's Proposed Second Five-Year Review Report does not adequately address scientific data and analyses presented by the National Atmospheric Administration and the New York State Department of Environmental Conservation that PCBs remain widespread and in greater amounts than expected throughout the Hudson River and that there is much more contamination left behind than originally estimated; and

WHEREAS, EPA determined dredging was needed to accelerate the timetable to reach remedial targets and deemed that delays of twenty years or more in reaching these targets were unacceptable;

WHEREAS, a peer-reviewed study published by the National Oceanic and Atmospheric Administration found that the remedial targets for Lower Hudson River may be reached decades longer than anticipated, since original model projections may have greatly underestimated the time to reach risk thresholds in the Lower Hudson River fish;

WHEREAS, the New York State Department of Environmental Conservation has concluded that the remedy may not be protective of human health and the environment, and that target fish tissue concentrations may not be met within time frames that EPA set out in the Record of Decision for the cleanup; and

WHEREAS, the dredging conducted by GE, which was completed years behind schedule, may not adequately allow for restoration of the Hudson River, and

WHEREAS, EPA admits that the remedy is not yet protective of human health and the environment in the Upper Hudson River, and that it will need eight or more years of

fish tissue data to determine whether the remedy is effective; and

WHEREAS, EPA admits that the Lower Hudson River is not recovering as anticipated and that it needs more needs more information about PCB contamination in that stretch of the River; and

WHEREAS, the presence of toxic PCBs in the Hudson River will continue to threaten the health and well-being of Hudson Valley residents and the environment for years to come.

#### NOW THEREFORE BE IT RESOLVED, that the

<u>Town of Stuyvesant</u> hereby urges EPA to review its Proposed Second Five-Year Review Report for Hudson River PCBs Superfund Site and (1) officially declare that the cleanup may not be protective of human health and the environment; (2) require GE to consider additional dredging in the Upper Hudson River;

(3) require GE to perform any additional necessary removal of contaminated soils and sediments, including those in the Champlain Canal, to restore economic opportunities; (4) require GE to conduct a full remedial investigation of the Lower Hudson River; and (5) declare EPA's firm commitment to the restoration of the Hudson River, a significant natural and economic resource of New York State.

The motion was seconded by Councilman Tom Burrall and was passed by unanimous vote.

### **County Government**

Supervisor Knott reported that the Shared Services Plan would be voted on at the September meeting of the full Board of Supervisors. He has information available if anyone is interested.

Supervisor Knott reported that one of the Shared Services projects was Opioid Forums around the County. One was being held on that evening, August 10<sup>th</sup> in Hudson; one on September 14<sup>th</sup> at the Kinderhook Town Hall; and an additional one will be in Canaan. Columbia and Greene Counties are working together on the forums.

*Solar Farms on Landfills* – There is an EPA study on landfills and the possibility of placing solar farms on them that will be discussed further in committee.

50 Grandinetti Dr. Sale (Commerce Park) – There will be a closing at the end of August for the 10 acre parcel and building to develop a County Training Center for firefighters and having a central area for all County Emergency Response Vehicles.

### <u>New Business</u>

*Veterans' Exemption Local Law #2 of 2017* – Supervisor Knott asked Town Clerk Melissa Naegeli to take a roll call vote on the proposed Local Law that was reviewed at the Public Hearing in advance of the meeting. The result of the roll call vote was 4 Yeas and 1 Absent; Local Law #2 of 2017 was adopted.

The Empire Trail meeting was being held at ICC this evening. Supervisor Knott reported that he had met previously with representatives and there was a draft map in the meeting room of where the trail will go. Kathy Schneider added that it was more of a presentation and that 2.62 miles of the trail would go through Stuyvesant. Carl Williams reported that the presentation only covered the "good stuff" and that there were a lot of questions from property owners about liability. He suggested the new trail stay along State lands along the river. Supervisor Knott added that there were concerns from the Town regarding maintenance responsibilities.

Supervisor Knott announced that 2018 Budget Worksheets had been distributed to all Department heads and that the first Budget Workshop would be held at the Board's regular Workshop meeting on the first Thursday of September (September 7<sup>th</sup>).

Supervisor Knott presented to the Board proposed Local Law #3 of 2017 regarding Littering and Dumping. There continues to be a problem with littering at Town parks. A Public Hearing was set to hear comments for September 14<sup>th</sup> at 7pm.
